高風險情況包括：

- 曾患侵入性肺炎球菌病、腦脊液滲漏或裝有人工耳蝸；
- 長期心血管疾病（高血壓而沒有併發症除外）、肝病或腎病；
- 新陳代謝疾病包括糖尿病或肥胖（體重指數 30 或以上）；
- 免疫力弱（因情況如無脾、人類免疫力缺乏病毒感染/愛滋病或癌症/類固醇治療引致）；及
- 長期神經系統疾病致危及呼吸功能、難於處理呼吸道分泌物、增加異物入肺風險或欠缺自我照顧能力。

High-risk conditions include :

- History of invasive pneumococcal disease, cerebrospinal fluid leakage or cochlear implant;
- Chronic cardiovascular (except hypertension without complications), lung, liver or kidney diseases;
- Metabolic diseases including diabetes mellitus or obesity (Body Mass Index 30 or above);
- Immunocompromised states related to weakened immune system due to conditions such as asplenia, Human Immunodeficiency Virus infection/Acquired Immune Deficiency Syndrome or cancer/steroid treatment; and
- Chronic neurological conditions that can compromise respiratory functions or the handling of respiratory secretions or increase the risk for aspiration, or those who lack the ability to take care of themselves.

備註 Remarks:

- 根據疾病預防疫苗科學委員會的最新建議，從2024年8月5日開始，政府疫苗接種計劃的十五價疫苗將取代現有的十三價疫苗。目前，65歲或以上並有高風險狀況的長者可繼續於疫苗資助計劃中接種受資助的十三價疫苗。然而，參與疫苗資助計劃的醫生應儘量遵循疾病預防疫苗科學委員會的建議，將十三價疫苗替換為十五價疫苗。
Starting from 5 August 2024, PCV15 will replace the existing PCV13 under the Government Vaccination Programme (GVP) following the latest recommendation from the Scientific Committee on Vaccine Preventable Diseases. Currently subsidised PCV13 will continue to be provided to elderly aged 65 or above with high risk conditions under the Vaccination Subsidy Scheme (VSS). However, VSS doctors are recommended to follow SCVPD's recommendation and replace PCV13 with PCV15 as far as practicable.
